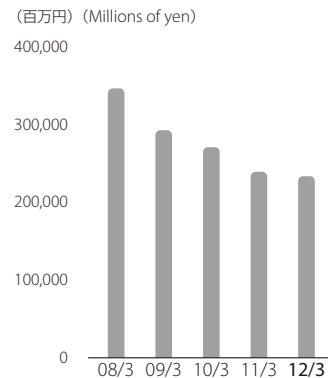

## 地域別売上高(2012年3月期) Sales by Region (Year ended March 31, 2012)



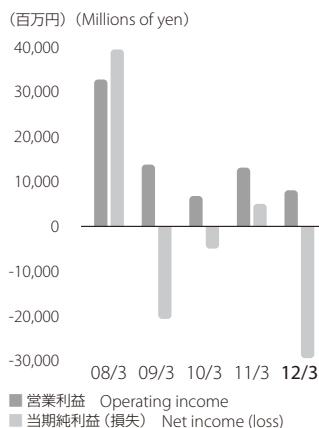

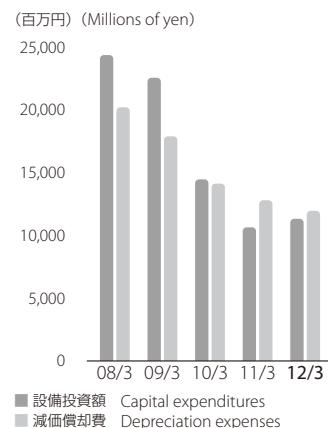

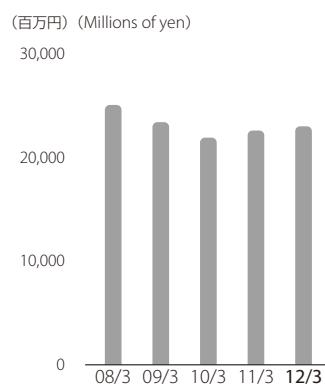

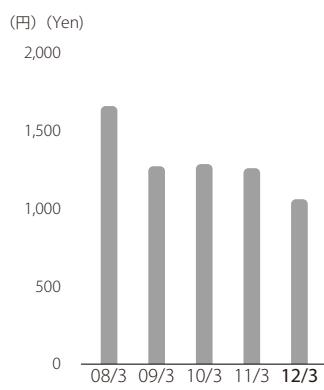

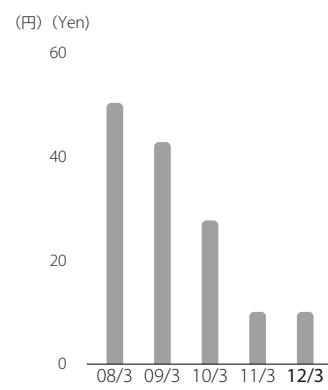

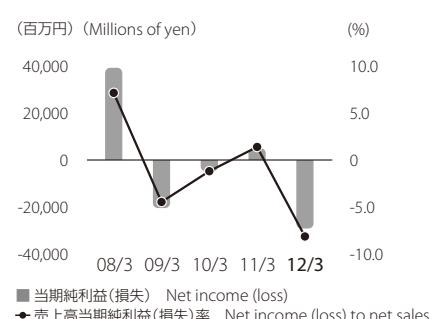

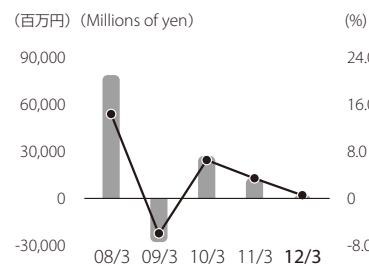

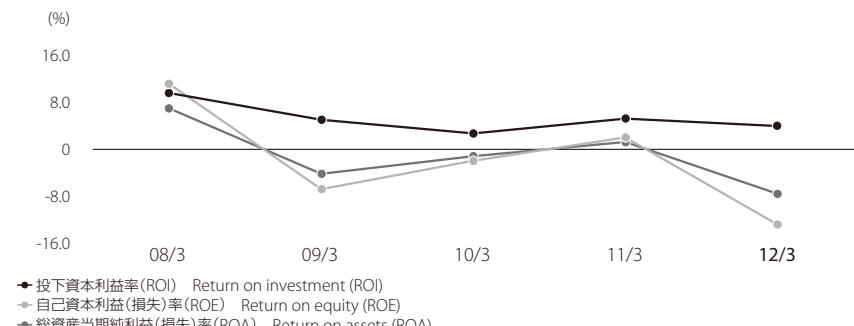

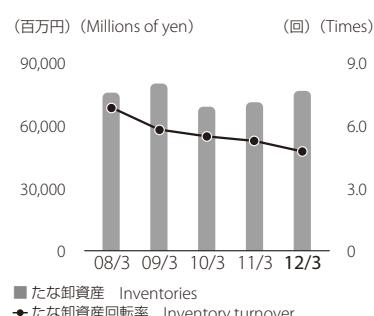

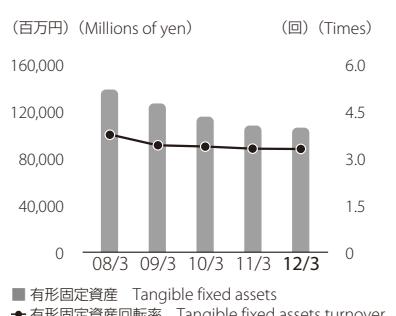

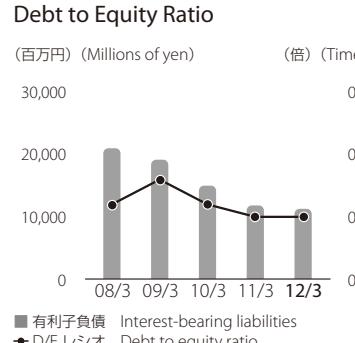

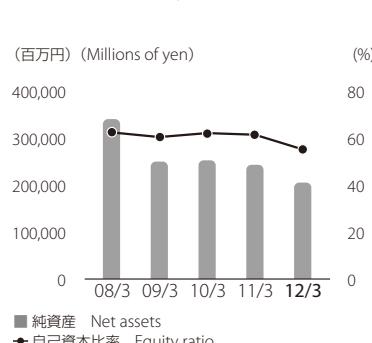
#### Interest-Bearing Liabilities/ Debt to Equity Ratio
