## WORLD HEARING DAY 2022 HEADPHONES SWEEPSTAKES (THE "SWEEPSTAKES")

## **OFFICIAL RULES**

- **ELIGIBILITY.** NO PURCHASE NECESSARY TO ENTER OR WIN. The Sweepstakes is open to legal residents of and who currently reside in the 50 United States (including District of Columbia), are 18 years of age or older at time of entry, who have access to the Internet throughout the Sweepstakes, and are Yamaha My Account members. My Account Membership is free. Online Entries must be received by Yamaha no later than 11:59:59 pm (PT) on March 24, 2022.

Mail-In Entries must be postmarked during the Sweepstakes Period and received by Yamaha no later than April 8, 2022.
