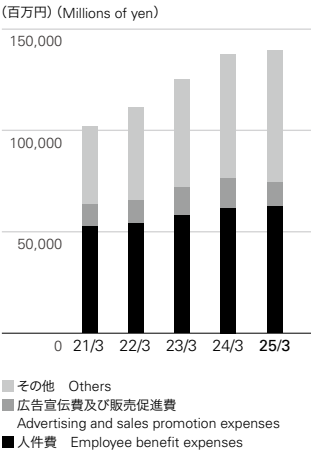

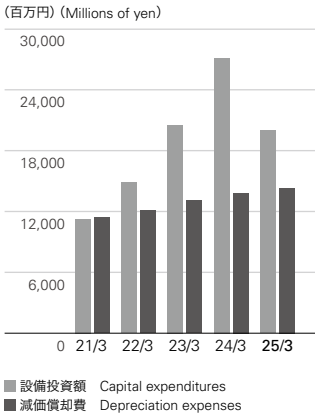
地域別売上収益 (2025年3月期)

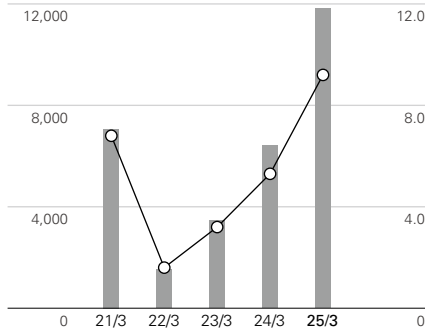

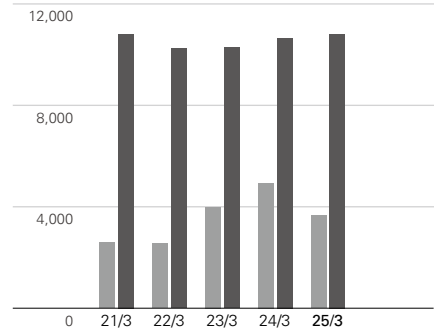

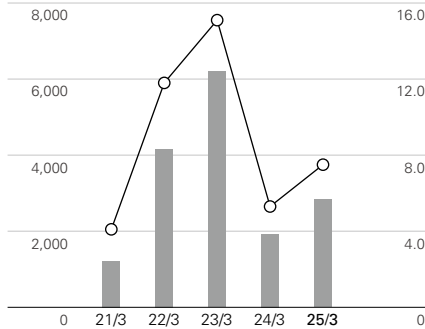

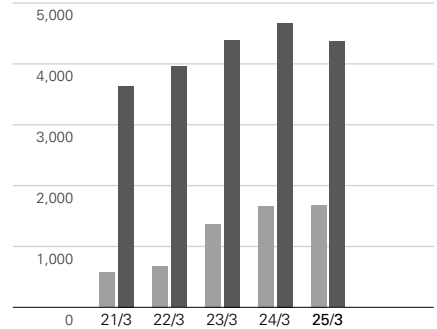

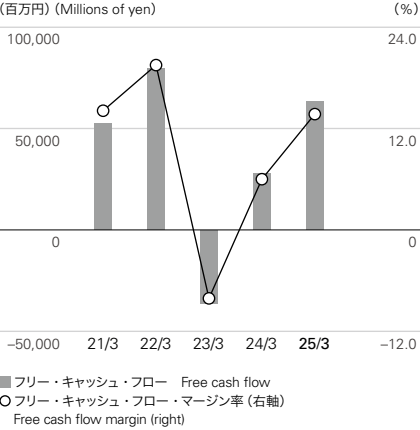
事業利益／売上収益事業利益率

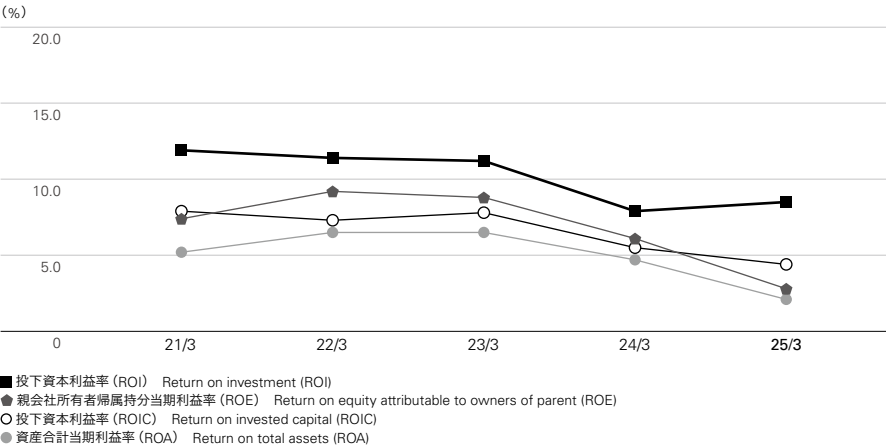

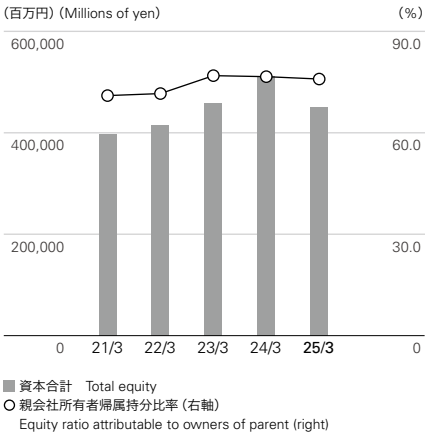
流動資産／流動比率

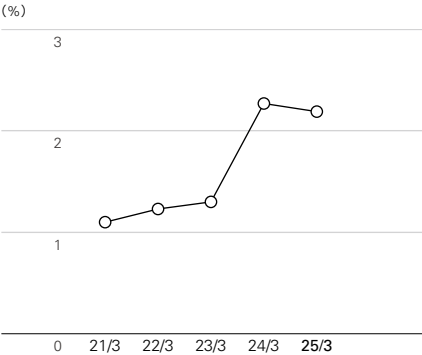

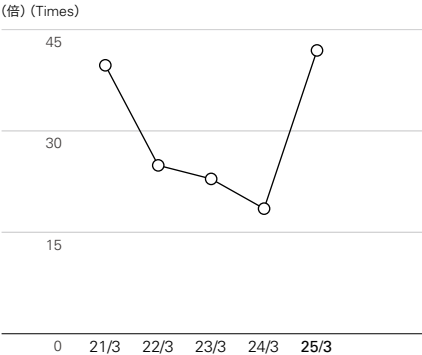

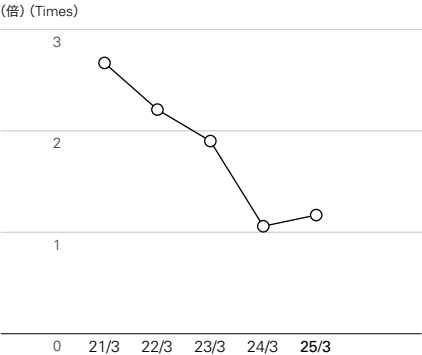
配当利回り
